

# Swimming Pool

## Plant Operation Program

The Swimming Pool Plant Operation Program has been developed to successfully meet the training needs of individuals supervising water quality in swimming pools in the aquatics industry and private pools. The program is delivered by the Australian Swimming Coaches and Teachers Association (ASCTA) via a self-paced learning program which allows participants to choose when, where and how they learn with flexible commencement and program duration. Supervised on the job training and a competency assessment process are also required once the theory component is completed.

Enrolments are accepted at any time for this course.

The two objectives of the Swimming Pool Plant Operation Program are to provide:

- a. the essential **technical knowledge and skills** to competently operate and maintain a swimming pool.
- b. **On the job training and assessment** for those wishing to gain a Statement of Attainment with:
  - **SISCAQU001 Test Pool Water Quality**
  - **SISCAQU003 Maintain Aquatic Facility Plant and Equipment**
  - **SISCAQU004 Develop and Implement Pool Water Maintenance Procedures**
  - **BSBRK401 Identify Risk and Apply Risk Management Processes**

- Pool Tests
- Regulations
- Responding to Contamination Incidents
- Record Keeping
- Chemical Balance of Pool Water
- Operation of Aquatic Facility Plant & Equipment
- Conducting Tests on Aquatic Facility Plant & Equipment
- Identifying Faults and Initiating Corrective Procedures
- Adjust Disinfectant Levels & Water Balance

# Terms and Conditions

## To meet all requirements, Program Students must:

- Personally, undertake all theory content of the Program within 12 months of commencement or have gained Recognition of Prior Learning for one or a number of lectures.
- Complete assessable assignments to a satisfactory standard within 12 months of commencement. These are mainly in the form of multi-choice and true/false responses. No materials are to be written by any other person except where due reference is made.
- Undertake monitoring and maintenance of water quality to a satisfactory standard in an on the job situation and be deemed competent.

## Recognition of Current Competency (RPL)

Some potential Program Students may be able to satisfy all or some of the competency requirements for accreditation without having to undertake the Program.

## To participate, Program Students should:

- be 16 years of age at Program commencement and must be 17 years of age to be accredited;
- read these Terms and Conditions, complete the Enrolment and send with payment to ASCTA

ASCTA will mail you the program lecture notes and assignments within 28 days of receiving your enrolment. (Usually within 7 working days)

## 12. PRIVACY STATEMENT

## 13. STUDENT DECLARATION

ASCTA, in conjunction with Swimming Australia Ltd (SAL)

The SAL Member Welfare Policy makes it a breach of the policy for a Prohibited Person (*defined as a person who has been convicted of a Serious Sex Offence*) to work or seek work in the following roles:

- As a coach or teacher of swimming who may be appointed or seeking appointment (*whether employed, contracted or otherwise*) for reward

Coaches and Teachers of swimming applying to become members of ASCTA also become members of SAL (*except for ASCTA 'Associate Members'*) and must comply with SAL's Member and Child Welfare Policies.

ASCTA reserves the right to reject a membership application of otherwise qualified persons (*with the exception of 'Associate Member' applications*) if:

- A Prohibited Person Declaration has not been signed, or
- Where this declaration reveals the person is a Prohibited Person
- The SAL Member Welfare Policy defines a Serious Sex Offence to mean an offence involving sexual activity or acts of indecency including but not limited to Rape; Indecent assault; Assault with intent to have sexual intercourse; Sexual assault; Incest; Sexual penetration of child under the age of 16; Indecent act with child under the age of 16; Sexual relationship with child under the age of 16; Sexual offences against people with impaired mental functioning; Abduction and detention; Procuring sexual penetration by threats or fraud; Procuring sexual penetration of child under the age of 16; Bestiality; Soliciting acts of sexual penetration or indecent acts; Promoting or engaging in acts of child prostitution; Obtaining benefits from child prostitution; Possession of child pornography; Publishing child pornography and indecent articles
